Rules

Safety

No player can take the field with bare feet or while wearing jewellery of any kind. All watches, necklaces, dangling earrings, bracelets, rings which are not bands MUST be removed prior to the game. The referee will ask any player breaking this rule to remove the piece of jewellery. Keys and Cell phones are not allowed.

Liability Release Form

All players Must Sign Liability Release Form

Shoes

It is compulsory for all players to wear appropriate enclosed sports shoes. Moulded-soled shoes or boots with tags will not be permitted under any circumstance. Players are also not permitted to wear work boots or hiking boots.

Contact between bubbles

It is forbidden to hit a player from behind or to aim your bubble at another player's legs. . It is also forbidden to fiercely go at a player who does not have the ball, or a player who is down trying to get up. You must play the ball and follow the game. Do not bump another player without making sure he/she saw your first.

Referee

The referee is directly responsible for the game and ensuring the described rules are adhered to. They are responsible for the safety of the players; and the timing and conduct of the game. They have a duty to be respectful and considerate to teams, act in an unbiased manner and ensure the game remains social and enjoyable for all involved.

Disciplinary Sanctions

This competition is social. Any rough play, abusive language, bickering or challenge to the referee's authority etc. will not be tolerated. These judgements will be at the discretion of the referee and his/her decision is final.

Hygiene and respect –

After the game, you must clean your bubble (out of respect for those who will use the bubble next.) We will provide you with cleaning solution and a cloth. This will only take a few seconds. Thank you for your collaboration.
